#### 1. CALL TO ORDER AND ACKNOWLEDGEMENT

Mayor Stone called this Public Hearing and Regular Meeting of Council to order at 6:01 p.m., recognizing with gratitude that it was taking place on the traditional, unceded territory of the Stz'uminus First Nation.

#### 3.1.1 Outline of Public Hearing Process - Mayor Stone

Mayor Stone outlined the Public Hearing process and stated that the public would have the opportunity to provide their comments to Council about Bylaw Nos. 2129 and 2132.

He advised that staff would introduce the proposed bylaw amendments, followed by public submissions. He reminded the public that the content of submissions would be made public and form a part of the public record for the Hearing, and that the function of Council at a Public Hearing is to listen rather than to debate the merits of the proposed bylaws, although they may ask clarifying questions. He advised that once everyone had an opportunity to be heard, the Public Hearing would be closed and no further submissions or comments could be accepted by members of Council.

#### 3.1.2 Introduction of Bylaws and Statutory Requirements - Planner, Development Services

Julie Thompson, Senior Planner, Development Services, introduced "Town of Ladysmith Zoning Bylaw 2014, No. 1860, Amendment Bylaw (No. 53) 2022, No. 2129" and "Town of Ladysmith Zoning Bylaw 2014, No. 1860, Amendment Bylaw (No. 55) 2022, No. 2132" as the subjects of the Public Hearing.

Ms. Thompson advised that, if approved, Bylaw No. 2129 would:

- amend the Zoning Bylaw by rezoning the property at 1152 Rocky Creek Road from Live/Work Industrial (I-1A) to Light Industrial (I-1); and
- allow Cannabis Cultivation and Cannabis Processing within an enclosed building under standard licences from Health Canada on a site-specific basis on 1152 Rocky Creek Road.

She noted that, if approved, Bylaw No. 2132 would allow Cannabis Cultivation and Cannabis Processing within an enclosed building

under standard licences from Health Canada on a site-specific basis at 1144 Rocky Creek Road.

Ms. Thompson also confirmed the Public Hearing notification and engagement process. Notice of this Public Hearing was published in the Ladysmith Chronicle on January 19, 2023, posted on the Town's website and community notice boards, and mailed and delivered to all properties located within 60 metres of the subject properties.

A copy of the Notice, the proposed bylaws, and background information were made available at the front counters of City Hall and Development Services and were available on the Town's website for the Notice period. Staff in the Development Services office were available to respond to questions prior to the Public Hearing. Ms. Thompson noted that as of noon on Tuesday, January 24 three submissions related to the proposed bylaws had been received.

Mayor Stone invited the applicants to make the first submission, but they were not in attendance.

220 High Street Fire Monitoring System Replacement

#### **RECOMMENDATION:**

That Council direct staff to include \$55,000 in the 2023-2027 Financial Plan for the Fire Monitoring System Replacement at 220 High Street with the funds to come from the Protective Services Reserve.

#### **EXECUTIVE SUMMARY:**

The current fire alarm system in the original building is no longer functioning properly and requires replacement. The existing wireless system has been sending false alarm signals due to weak signals. A new system will be hard wired and consistent with the system being installed in the recent childcare spaces expansion. Integrating both systems together will be integral to having a safe building with a working fire alarm system.

Quotes for the replacement of the fire monitoring system are around \$52,000, which includes a small contingency and complete installation of the new system, as well as oversight from MKM contracting, the onsite construction management for the new childcare space project.

#### **PREVIOUS COUNCIL DIRECTION:**

N/A

#### **INTRODUCTION/BACKGROUND:**

Over the past year, the fire monitoring system at 220 High Street has been showing signs of failure issues including sending multiple false alarms. Components necessary to maintain this system are becoming obsolete and challenging to source. Shortly after the construction started for the new addition, it was identified that the current alarm system in the original building would not be compatible with the new system being installed. The electrical engineer made attempts to utilize the existing system, however this system is no longer available.

Three estimates were obtained, with the proposal from Osprey Electrical Ltd. being the least expensive. Osprey Electrical Ltd. is the current electrical contractor working on the new system for the 220 High Street childcare spaces project. Osprey provided the design for the new system and a design for the existing section of the building. It is very important that the two systems work together and operate as one system.



#### ALTERNATIVES:

Council can choose to:

- 1. Not replace the fire monitoring system and continue with status quo. This option is not recommended as there is significant risk with the potential for the current fire monitoring system to fail completely.
- 2. To fund this project differently, i.e. by reallocating funds from other projects in the 2023 Capital Plan.

#### **FINANCIAL IMPLICATIONS:**

As there are no funds currently budgeted to complete this project, staff recommend that this project be funded from the Protective Services Reserve.

#### **LEGAL IMPLICATIONS:**

A final occupancy permit for the new addition could be denied without a fully functional fire alarm system.

#### **CITIZEN/PUBLIC RELATIONS IMPLICATIONS:**

Not completing the replacement could result in impacts to the operations of the BGC childcare facility.





#### A Bylaw to amend "Ladysmith Officers and Delegation of Authority Bylaw 2016, No. 1905"

The Council of the Town of Ladysmith in open meeting assembled enacts the following amendment to "Ladysmith Officers and Delegation of Authority Bylaw 2016, No. 1905":

1. Replace Section 19 "Powers and Duties of the Director of Development Services" with the following:

" 19. Council hereby delegates to the Director of Development Services the powers, duties, and functions to issue:

- a. development permits for signage and façade improvements;
- b. riparian development permits;
- c. hazard land development permits;
- d. development permits for Coach House Dwellings that are not more than 5.0 metres in height; and
- e. amendments to development permits."
